

RESOLUTION NO. 07-01-10-04

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RANCHO SANTA MARGARITA, CALIFORNIA, ADOPTING THE SECOND BATTALION, FIFTH MARINE REGIMENT, FIRST MARINE DIVISION, UNITED STATES MARINE CORPS, CAMP PENDLETON.

WHEREAS, Rancho Santa Margarita has a history of active community involvement and volunteerism and the City would like to expand and show appreciation for American military forces that are engaged in defending or are preparing to defend and support the interests and principles of the United States; and

WHEREAS, in June 2006, the City Council was first approached with the concept of officially adopting the 2nd Battalion, 5th Marine Regiment, 1st Marine Division; and

WHEREAS, on December 13, 2006, the Rancho Santa Margarita City Council directed staff to prepare a resolution of support to officially adopt the 2nd Battalion, 5th Marine Regiment, 1st Marine Division, which is based at Camp Pendleton, and

WHEREAS, the City of Rancho Santa Margarita is pleased to be participating in this communitywide effort and hopes that residents, businesses, service clubs, non-profit organizations, and others will become involved in supporting the members of the 2nd Battalion, 5th Marine Regiment, 1st Marine Division who are serving our country abroad and to support their families while they are away.

NOW THEREFORE, the City Council of the City of Rancho Santa Margarita, California, does hereby RESOLVE, DETERMINE and ORDER as follows:

That the City of Rancho Santa Margarita formally adopts the Second Battalion, Fifth Marine Regiment, First Marine Division based at Camp Pendleton, and encourages all residents and businesses to support this communitywide effort.
